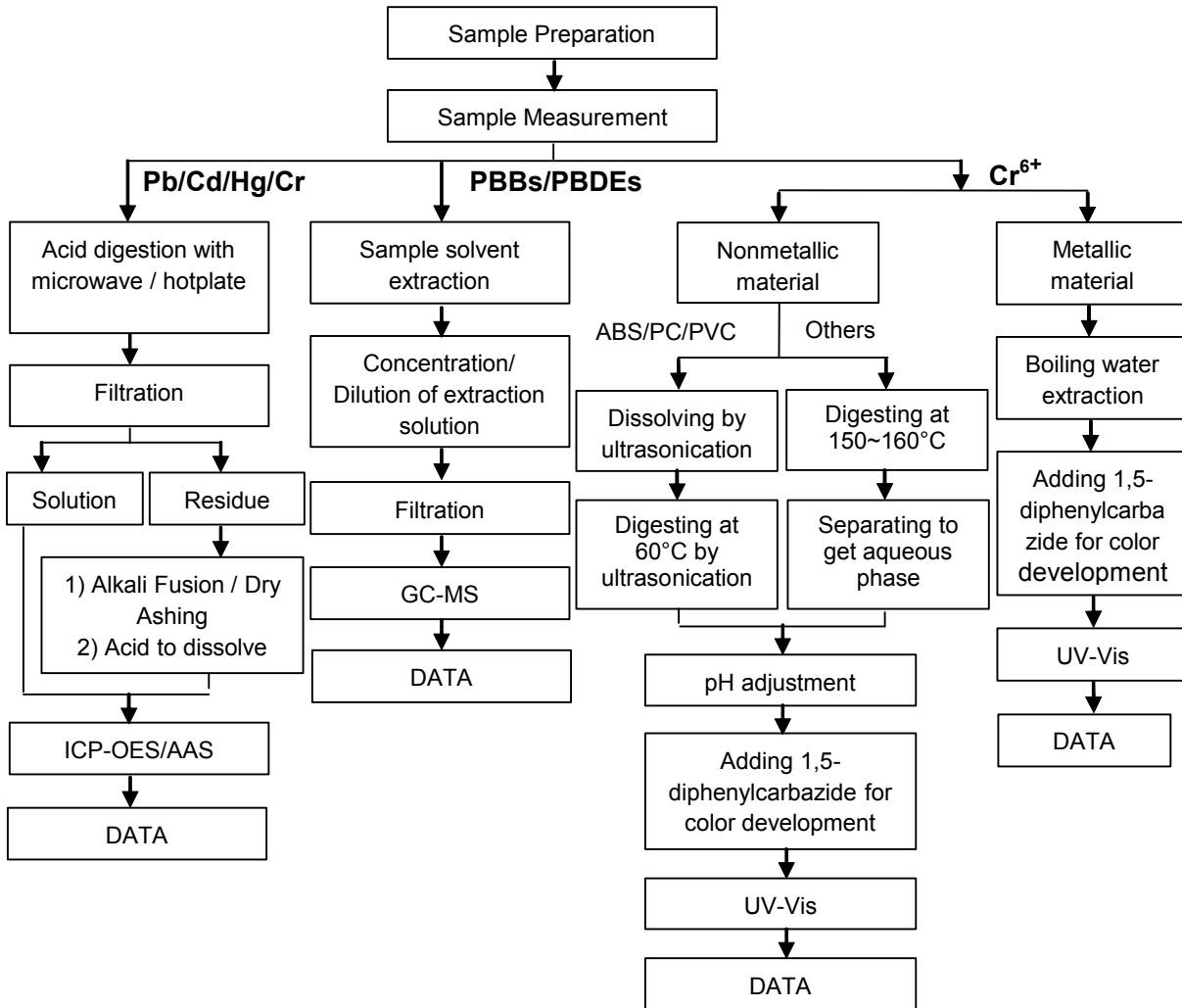

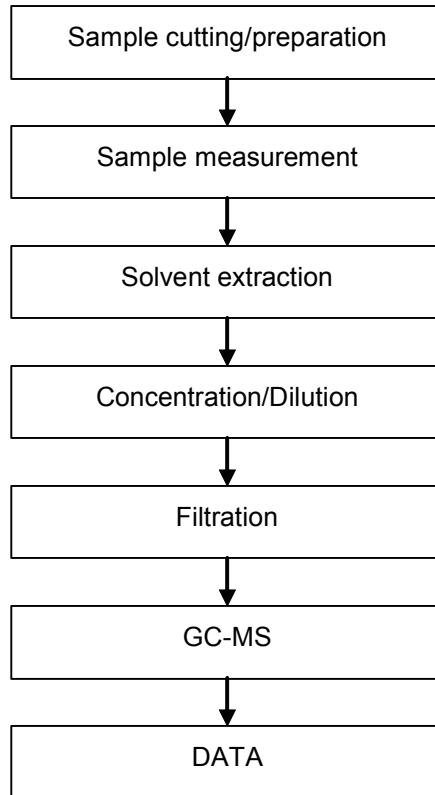

Phthalates Testing Flow Chart

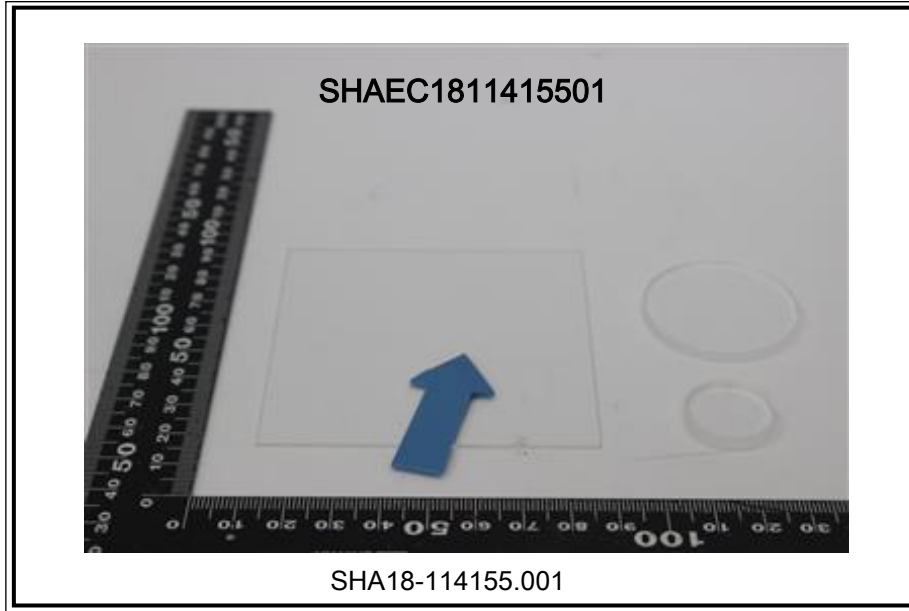
